- 1. The Chairman, Standing High Level Procurement Committee (SHLPC), Ministry of Transport, Highways and Urban Development on behalf of Sri Lanka Land Development Corporation (SLLDC) invites sealed Tenders from eligible and qualified tenderers for mining, pumping and stockpiling of sand from off-shore at Kerawalapitiya, Sri Lanka.
- 2. Approximately 2.3 million m³ of off-shore sand shall be mined, of which 300,000 m³ will be used for land reclamation and 2,000,000 m³ for stockpiling. The Employer may request up to 1,000,000 m³ as an additional quantity for reclamation and/or stockpiling, to be executed at the same rates quoted in the Bill of Quantities.
- 3. Sand shall be mined from an approved off-shore borrow area (47 km²) located 10–16 km from shore, and pumped to the designated 42-hectare land at Kerawalapitiya. The material shall be well-graded medium to coarse sand average grain size (D 50 Value) in the range of 0.5 mm to 1.2 mm.
- 4. The time for completion the project is 120 days.
- 5. Tendering will be conducted through the International Competitive Bidding (ICB) procedure.
- 6. - 7. Basic qualification required:
 - At least 5 Nos. off-shore sand mining and pumping projects of 1,500,000 m³ or more (as a scope of a single project), carried out using off-shore dredgers, booster pumps, and pipelines for stockpiling or inland reclamation at least 1 km onshore or both, since January 2010 to June 2025.
 - At least 1 No. off-shore sand mining and pumping project of 1,000,000 m³ or more (as a scope of a single project) for stockpiling since January 2005 to June 2025. The same projects may be used to satisfy both requirements.
- 8. A margin of preference for eligible domestic Tenderers shall not be applied
- 9.
